### **Premium Events Collection™ - Presale Ticket**

Platinum Card® and Centurion® Members have access to purchase Premium Events Collection™ Presale Tickets for select events and select seats, during a specified period prior to the general on-sale dates for those events. Tickets must be purchased using an eligible American Express Platinum Card® or Centurion® Card. When purchasing tickets, enter the 10-digit customer service phone number on the back of your eligible Card when prompted. An American Express Prepaid Card cannot be used to purchase tickets. Premium Events Collection Presale Tickets are sold by and fulfilled by third party ticket sellers (not American Express), and such tickets are subject to the rules, terms and conditions, prices and fees set by the ticket seller, event promoter and/or the venue. Premium Events Collection Presale Tickets are subject to availability and supply may be limited. Not all seats may be offered; purchase limits and blackout dates may apply. ### **Event Policies for the 2026 Food & Wine Classic in Charleston (the “Event”)**

A Food & Wine Classic pass and the official Food & Wine Classic in Charleston 2026 lanyard must be worn and properly displayed at all Classic events. Passes are non-transferable and will not be replaced if lost or stolen.

No one under 21 is permitted including infants and small children in child carriers. This policy pertains to all events including demonstrations, seminars, and Grand Tastings.

Resale of passes is not permitted.

Attendees must arrive at least 15 minutes prior to the seminar start time. Failure to do so may result in the release of pre-registered seats to the standby line. Pre- registration for a seminar does not guarantee a seat in the selected seminar(s). If you do not attend the seminar due to late arrival or any other reason, no refunds or make-goods will be provided.

### **Event Code of Conduct**
